Natural Resource Inventory

INTRODUCTION

The Natural Resource Inventory is a document containing a collection of links intended to help guide local planners, developers, property owners and the general public in accessing Natural Resource Regulations. Given the multitude and variability in development scenarios, the documents in this inventory are by no means the final authority on directing or permitting any type of development. This document should only serve as a general educational platform on potential Natural Resource Regulations applicable within Washoe County, NV.

What is a Natural Resource?

Natural Resource defined by the Regional Plan means: air quality, quality and quantity of surface water and groundwater; habitat for fish, vegetation, and wildlife; open space; flood plains; wetlands; aquifer recharge areas; stream channels; soils; scenic quality; and energy sources.

It is the intent of the Regional Plan to identify and manage significant natural resources in a manner that sustains those resources for future generations and considers each resource as part of a larger natural system. To carry out this intent, the Regional Plan requires the master plans and facilities plans of local governments and affected entities to recognize the interdependent functions and contributing values of rivers, wetlands, other water bodies, aquifer recharge areas, ridgelines, steep slopes, open space, greenways, recreation areas, and habitat for wildlife and vegetation.

What are the types of Natural Resources?

This natural resource inventory provides links related to five major natural resource areas as generally defined below:

- **Air:** This category includes but is not limited to air quality and air pollution control.
- **Land:** This category includes but is not limited to public and private land use and transportation planning, grading and drainage, public safety and services, and traffic controls for the region, including tribal lands.
- **Water:** This category includes but is not limited to water quality, water resource attainment and protection, water pollution control of point sources and non-point sources, planning for drinking water facilities and wastewater facilities, beneficial uses, and storm water and flood management.

- **Wildlife:** This category includes but is not limited to protection of wildlife and fauna habitats, including plans for threatened and endangered species.
- **Energy:** This category includes but is not limited to the provision and control of energy services, protection of energy resources, and conservation practices.

Where are you?

Several of the regulations are dependent on where you are located in Washoe County. The Regional Plan divides the regional planning area into three major types:

- **Truckee Meadows Service Areas (TMSA)** – the defined areas within which municipal services and infrastructure will be provided, characterized by high intensity core areas and existing urban and suburban areas. The TMSA includes lands governed by the City of Reno, City of Sparks, and unincorporated Washoe County.
- **Rural Development Area (RDA)** – area within the region located outside the TMSA where the character of development is mainly rural and new development is limited to one dwelling unit per five acres. Washoe County is the only local entity with jurisdiction in the RDA.
- **Future Service Areas (FSA)** – areas outside the TMSA which are identified for potential development beyond the 20-year planning horizon provided for in the Regional Plan. To add land to the TMSA from the FSA, the applicable jurisdiction must first prepare a natural resource management plan for the area to be added and must meet minimum density thresholds in its existing TMSA. Each of the three entities have defined FSAs.

In order to find a specific location, please refer to Map 1, Map 2, and Map 3 of the 2007 Truckee Meadows Regional Plan.

- If your land is located in Washoe County's portion of the RDA/TMSA area, ***Washoe County will be the primary contact for development on the land.***
- If your land is located in the City of Reno's TMSA area, ***the City of Reno will be the primary contact for development on the land.***
- If your land is located in the City of Sparks's TMSA area, ***the City of Sparks will be the primary contact for development on the land.***
- If your land is located in any FSA area, ***Washoe County will be the primary contact for development on the land.***

Organization of this Inventory

This inventory is divided into three major sections, as outlined below. The arrangement of this inventory is intended to facilitate fact finding for a range of development or educational scenarios. Those looking for natural resource information on a state level should consult Sections B and C, while those focused more at the regional or local level should consider Sections A and B in more detail.

- **Section A** provides links to the three local jurisdictions – City of Reno, City of Sparks or Washoe County based on the policies and regulations that apply to a specific land area (RDA, FSA, and TMSA).
- **Section B** provides links to those entities with policies and regulations *specific* to a natural resource category. They apply to all planning areas (RDA, FSA, and TMSA). This section is arranged foremost by the five resource areas – air, land, water, wildlife and energy – and subsequently by level of government starting at the federal level.
- **Section C** provides links to the federal, regional and state-level branches of environmental protection. These agencies administer the overarching policies and regulations that apply to most natural resource categories and all planning areas (RDA, FSA, and TMSA).

SECTION A. LOCAL POLICIES AND REGULATIONS:

There are levels of government that regulate and address issues in a *specific RDA, FSA or TMSA land area*. They are listed below.

1. WASHOE COUNTY (RDA, FSA and TMSA):

a. Washoe County Comprehensive Planning: The Washoe County Comprehensive Planning Department administers the Washoe County Comprehensive Plan (12 Area Plans/1 Open Space Plan) and the Washoe County Development Code. These documents contain policies/regulations for conservation areas/open spaces, land use, transportation patterns, public services, and facilities. For details, please see the following:

The tribal membership consists of members from many tribes including the Paiute, the Shoshone, and the Washoe tribes. Among the controlled lands are a ± twenty-eight (28) acre colony located near downtown Reno, east and west of US Interstate 395, and south of the Truckee River, and a ± 1,960 acre reservation in Hungry Valley (± nineteen (19) miles north of Reno).

The US Environmental Protection Agency and Nevada Department of Environmental Protection have broad regulatory authority and address issues across *all natural resource categories, for all RDA, FSA and TMSA land areas*. These agencies may not need to be consulted for each planning or development activity but should be considered as a resource for providing a regulatory context.

1. The US Environmental Protection Agency (USEPA): The USEPA leads the nation's environmental science, research, education and assessment efforts. The mission of the Environmental Protection Agency is to protect human health and the environment. The EPA Pacific Southwest - Region 9 administers 11 programs related to the quality of the environment, which include but are not limited to, air, water, toxic waste, wetland protection, and pollution control through enforcement measures and clean-ups. They also allocate and administer grants.

2. The State of Nevada Department of Conservation and Natural Resources, Division of Environmental Protection (DCNR-NDEP): The Nevada State Law is administered through the *Nevada Revised Statutes* (NRS), Special Acts of the Nevada Legislative Counsel Bureau, and the Nevada Administrative Regulations (NAC). The DCNR-NDEP administers several sections of State Law in order to protect public health and sustain healthy ecosystems. The regulations cover three natural resource areas (Air, Land, and Water) and the regulations website page listed below provides more information. The division administers programs and issues permits related to:

- Air Quality Program: ambient air quality, mercury control, chemical accidents, alternative fuels.
- Air Pollution Control Permits: based on tons of air pollutants (class 1, 2, and 3). Class 1 is the largest amount.
- Water Quality Program: ambient water quality, set water quality standards, Total Maximum Daily Loads (TMDLs), certify laboratories.
- Water Pollution Control Permits: point source/storm water discharges, underground injection.
- Safe Drinking Water: sanitary surveys of public water systems and groundwater protection.
- Mining Regulation/Reclamation Program: controls various mining activities.
- Hazardous/Solid Waste Management Program: generators, transporters, treatment, storage, disposal, recycling, landfills, transfer stations.
- Corrective Action Program: Brownfield restoration, underground storage tanks.
